

POM International Terminal Service Fees – 2014 With Effect 01st July 2014

1. International Export Storage Fee

For general freights lodged 36 hours or less prior to the scheduled time of departure

Special storage (including cool room and freezer) lodged within six hours of the scheduled time of departure

Note:

- 1. Air Niugini Freight will not accept freight in excess of the period stated above without prior management. On occasion that special arrangements are made storage charges (inclusive of GST) will be negotiated. Please refer to Imports Storage Charges as a guide.
- 2. Lodgement times must be within the terminal's normal published acceptance hours
- 3. The "no charge" storage period is subject to space availability
- 4. Air Niugini Freight will not be held liable for spoilage of product left within its care

For the processing and electronic reporting of the air waybill details to Customs with FWB data provided pre-acceptance

6. International Export Terminal Fee (BSC)

For all International freight lodgements through Air Niugini Terminal, a flat International Export Terminal Fee will be charged

Export freight must be tendered in accordance with the accompanying documentation or pre-received electronic data

For Carriage on Air Niugini Flights:

Where freight is tendered loose the following loading fees will be applied; Individual shipment weight from 0 - 200kgs

Individual shipment weight from 201 - 3'500kg Individual shipment weight in excess of 3'501kg

- The fee is charged at the total AWB weight once the breakpoint has been exceeded

For Carriage on airlines handled by Air Niugini Freight:

8. International Export Valuable Handling Fee (VA)

9. International Export DG Acceptance (RAC)

10. International Import Document Fee

For the processing of electronic reporting of the air waybill details to Papua New Guinea Customs

11. International Import Storage Fee – General Cargo

Rate

For loose freight removed within 72 hours commencing 2359 hours day of check-in, excluding initial Saturday, Sunday and /or Legal Holidays if occurring within 72 hours

For loose freight removed later than 72 hours after day of check-in (per 24 hours or part thereof), storage will be charged on a weekly per kilo rate charge as follows;

a) Within the One week period

b) Within the Second week period

c) Within the Third week period

d) Within the Fourth week period

e) In excess of more than 4 weeks

12. International Import Storage Fee - Specialised Cargo

Rate

 For Special loose freight that requires Cool Room Storage at the day of checkin, storage will be charged on weekly per kilo rate charge as follows;

a)	Within the One week period	K0.25 per kilo/per day
b)	Within the Second week period	K0.40 per kilo/per day
c)	Within the Third week period	K0.50 per kilo/per day
d)	Within the Forth week period	K0.65 per kilo/per day
e)	Within the Fifth week period	K0.80 per kilo/per day
f)	Within the Sixth week period	K1.00 per kilo/per day
g)	Within the Seventh week period	K2.00 per kilo/per day

For shipments held in ULD/s (shipper built) that requires Cool Room Storage at the day of check-in, following charges will apply;

Additional charge for extra day usage of the Cool Room facility

2) For Special loose freight that **do not require Cool Room storage**, removed within 12 hours commencing 2359 hours day of check-in

3. International Import Valuable Handling Fee

Where freight requires Special Handling such as retrieval from Security Lockers on the aircraft, Security Room storage, either picked up airside or via the Air Niugini Freight facilities, following fee will be applied

14. International Import Handling Fee

Rate

For all shipments arriving through the Air Niugini Freight Terminals the following fees apply;

a) For loose freight Minimum Charge K0.02 per kg K20.00 per shipment

 For shipments arriving as "Shipper Loaded" on the air waybill and delivered intact (ULD rated or number of pieces refers to the number of ULS/s)
 OR

For freights arriving as multi-pieces loaded at origin as ULDs by shipper or their agent, manifested as one line only and delivered intact

Explanatory notes:

- 1. Effective **01**st **July 2014**, subject to variation with a minimum 15 days
- 2. The air waybill refers to both a paper version (HAWB) or an electronic version (FWB) and a paperless version is referred to a eFreight (eAWB)
- 3. The house air waybill refers to both a paper version (HAWB) or an electronic version (FHL)
- 4. Storage fees when applied are in additional to other fee applications
